THIS AMENDMENT is by and between the City of Galveston, a municipality incorporated under the laws of the State of Texas, Galveston Texas, and Republic Services, Inc, a company, located at 5301 Brookglen, Houston, Texas 77017. Except as set forth in this Amendment, the Agreement is unaffected and shall continue in full force and effect in accordance with its terms.

WHEREAS, the City and Republic Services entered into an Agreement, Contract# COG-CON-16-032, effective February 19, 2016 for services related to transportation of dewatered domestic wastewater “sludge” here in RFP# 15-13 Transportation of Dewatered Domestic Wastewater Sludge.

WHEREAS, the City and Company, agree to make the following amendment a part of the Agreement.

Contract Term: It is mutually agreed and understood by and between the undersigned contracting parties to amend the previously executed agreement as follows:

The City shall have as its sole option the ability to extend the term of this agreement by exercising one (1) two-year option.

As stated in Section II – Scope of Requested Services, paragraph 1, page 16, of the Request for Proposals the following language is hereby deleted and has no force and/or effect in this agreement. ~~“These services may be extended, at the sole discretion of the City, on one occasion for a maximum term of ten years as described in the Agreement.”~~
