

**MINUTES OF THE CITY COUNCIL OF THE CITY OF GALVESTON
REGULAR MEETING - FEBRUARY 25, 2021**

2/25/2021 - Minutes

1. DECLARATION OF A QUORUM AND CALL MEETING TO ORDER
With a quorum present, the meeting was called to order at 5:02 p.m.
2. ROLL CALL

8. ORDINANCES (NOT REQUIRING PUBLIC HEARINGS)

- 8.A. Consider For Approval An Ordinance Of The City Of Galveston, Texas, Declaring A State Of Disaster And Emergency In The City Of Galveston Related To The Winter Storm Of 2021; Confirming And Ratifying The Declaration Of The Local State Of Emergency Signed By The Mayor, Making Various Findings And Provisions Related To The Subject, Providing For A Penalty And Providing For An Effective Date. (Legal)

Ordinance No. 21-004 was read by caption. Motion was made by CM Robb, second by CM Johnson, to approve the ordinance. Unanimously approved.

- 8.B. Consider For Approval An Ordinance Of The City Of Galveston, Texas; Extending The State Of Emergency And Disaster Related To The Covid-19 Virus Until April 30, 2021, Extending Certain Emergency Orders Ratified By City Council Relating To The Operation Of Electronic Amusement Machines, The Suspension Of Building Code And Flood Plain Regulations For Placement Of A Covid 19 Temporary Screening Facility At Scholes Airport; Requiring Commercial Entities Providing Goods Or Services Directly To The Public To Develop A Health And Safety Policy Mandating The Wearing Of Masks In Their Facility, Requiring The Wearing Of Face Masks In Public And Restricting Mass Gatherings; Making Various Findings And Provisions Related To The Subject, Providing For A Penalty And Providing For An Effective Date.

Ordinance No. 21-006 was read by caption. Motion was made by CM Johnson, second by MPT Collins, to approve the ordinance extending the state of emergency and disaster, and removing orders except those related to the mask order and the restriction of mass gatherings. The Legal Department will bring back at the next meeting an ordinance to address the mask wearing that will include removing the fine from the business and putting it onto the individual if the business has a plan in place. The motion carried 5-2; CM Quiroga and CM Listowski opposed the motion.

- 8.C. Consider An Ordinance Amending The FY 2020 Operating Budget By Transferring \$1,526,606 From General Fund Balance To Create A One-Time Line Item Budget To Properly Record Hurricane Ike CDBG Housing Program Administration Expenses; Said Expenses Were Incurred From FY 2010 Through FY 2013 And Were Not Reimbursed By The General Land Office Using Grant Administration Funds; And Reimbursement Of Which Is Now Considered Tenuous And Contingent On A Number Of Events Of Uncertain Outcome. (M. Loftin)

Ordinance No. 21-005 was read by caption. Motion was made by Mayor Brown, second by CM Schuster, to approve the ordinance. Unanimously approved.

Consider For Approval A Resolution Of The City Council Of The City Of Galveston, Texas, Approving The Annual Aerial Spraying For Mosquito Control; Directing The City Secretary To Forward A Certified Copy Of This Resolution To The Galveston County Mosquito Control District; Providing For Findings Of Fact And Providing For An Effective Date.
- 9.C. Consider For Approval A Resolution Of The City Council Of The City Of Galveston Supporting The Bid For The 2024 Texas Recreation And Park Society, (Traps) Institute And Expo Submitted By The City Of Galveston's Parks And Recreation Department; Providing For Findings Of F Act And Providing For An Effective Date. (B. Sanderson)
- 9.D. Consider Approval Of A Contract With Triad Marine And Industrial Supply, Inc. For An All Hazard Response And Rescue Boat With Firefighting Capabilities (RFP 21-02) In The Amount Of \$208,422.00. Authorizing The City Manager To Execute All Necessary Documents Upon Final Approval By The City Attorney. (C. Olsen)

Consider For Approval The Purchase Of Eleven (11) Netmotion Mobility Software Licenses From Mobile Wireless LLC Utilizing DIR TSO 3810, 11 Laptops, Routers And Docking Stations From And Turn-Key Mobile, Inc. Utilizing The Texas DIR Contract (DIR-TSO-4025) And Seven (7) Licenses From CentralSquare (Formally Known As Sungard Public Sector, Inc) For A Total Cost Of \$108,311.09. This Purchase Will Supply Laptop Computers, Printers, Mounting Hardware, And Licenses To Upfit Eleven Marked Marshals Units With State-Of-The-Art Equipment To Allow The Deputy Marshal's To Perform Their Duties Reducing Face To Face Contact, And Enhance Their Ability To Work Independently In The Field. - Motion was made by MPT Collins, second by CM Listowski, to approve Item 9I. The motion carried 6-1; CM Quiroga voted against the motion.**

Consider For Approval The Purchase Of A Replacement Audio/Visual System For The Police Department's Interview Rooms Through WatchGuard, Utilizing The DIR-TSO-4163 Contract In The Amount Of \$16,110. This System Will Replace An Aged Outdated Solution Which Only Supports Video Through The Creation Of A DVD. The New Solution Will Store The Data On The Network In A Database For Easy Storage And Retrieval. (H. Dean)
- 9.K. Consider For Approval To Authorize The City Manager Or His Designee To Execute A Certification Of Consistency With The City's Consolidated Plan (HUD Form-50077-SL) For The Galveston Housing

Authority Program Year 2021 Annual Plan. (A. Law)

9.L. Consider For Approval Minutes Of The December 29, 2020 Regular Meeting, The January 7, 2021 Orientation Session, And The January 28, 2021 Workshop And Regular Meeting. (J. Williams)

9.M. Consider Prequalifying Jacobs Engineering To Compile A Detailed Scope And Negotiated Fee For Developing The City's Strategic Drainage Plan; Authorizing The City Manager To Execute All Necessary Documents Upon Final Approval By The City Attorney. (B. Cook)

Mayor Brown declared a conflict and did not participate in the discussion or vote on Item 10A.


Motion was made by CM Robb, second by CM Listowski, authorizing to expend additional funds of \$25,000. The motion carried 6-0.
