NOTICE OF SPECIAL ELECTION FOR THE CITY OF GALVESTON AVISO DE ELECCIÓN ESPECIAL PARA LA CIUDAD DE GALVESTON

The City Council of the City of Galveston ordered special elections for voters to (1) elect a person to the office of City Council Member to single-member District Two (2) for a term ending May 2024; and (2) for the purpose of submitting to the qualified voters of the City of Galveston, the following proposition to extend the existing one-half of one per cent sales and use tax:

El Concejo Municipal de la Ciudad de Galveston ordenó elecciones especiales para que los votantes (1) elijan a una persona para el cargo de Miembro del Concejo Municipal para el Distrito Dos (2) de un solo miembro por un período que finaliza en mayo de 2024; y (2) con el propósito de presentar a los votantes calificados de la Ciudad de Galveston, la siguiente propuesta para extender el impuesto sobre las ventas y el uso de la mitad del uno por ciento existente:

ADOPTION OF THE EXISTING ONE-HALF OF ONE PER CENT SALES AND USE TAX FOR THE FOLLOWING TYPES OF PROJECTS FUNDED WITH THE SALES AND USE TAX TO BE APPORTIONED AS PROVIDED AND SET FORTH: ONE-EIGHTH OF ONE PERCENT FOR BEACH REMEDIATION PROJECTS ALONG THE GULF OF MEXICO, INCLUDING BEACH RENOURISHMENT; ONE-EIGHTH OF ONE PERCENT FOR PROJECTS RELATED TO RECREATION AND COMMUNITY FACILITIES INCLUDING PARKS AND PARK FACILITIES; ONE-EIGHTH OF ONE PERCENT FOR PROJECTS RELATED TO INFRASTRUCTURE IMPROVEMENTS; AND ONE-EIGHTH OF ONE PERCENT FOR PROJECTS RELATED TO THE PROMOTION OR DEVELOPMENT OF NEW OR EXPANDED BUSINESS ENTERPRISES, INCLUDING THE MAINTENANCE AND OPERATION OF SUCH PROJECTS.
