## DEPOSIT FORM

I hereby obligate myself to pay said city at its proper office, the full sum due by me for said service, when and as the same accrues under the regulations and ordinances for the said City of Galveston now in force or which may hereafter be adopted or enacted.

I obligate myself to abide by the rules, regulations and ordinances of the City of Galveston, now in force, or hereafter adopted or enacted by the city council of the City of Galveston Utility Department, or discontinue service.

The deposit posted to this account will be absorbed to the final bill and remaining balance of deposit will be refunded once final reading has been made. At no time while the deposit is being held by the City of Galveston will it accrue interest. I also understand that in order to keep the deposit from increasing, the account must be kept in good credit standing.

I understand that if, through research it is found that I have an old account or final bill that has not been paid, that balance will be transferred to this account for payment.

Delinquency notices will be sent to customers in arrears. The customer has 10 business days from the date of the notice to make satisfactory payment or the City of Galveston shall terminate water service. A \$40.00 reconnect fee will be charged for any terminated water service and additional deposit may be required from a customer who has service terminated 2 times within a 12-month period.
